A RESOLUTION AUTHORIZING THE HONORABLE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPALITY OF TAYTAY, RIZAL, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF MIGRANT WORKERS (DMW), REPRESENTED BY ITS CALABARZON REGIONAL DIRECTOR, ATTY. APRIL R. CASABUENA, FOR THE ESTABLISHMENT OF THE DMW RIZAL PROVINCIAL OFFICE WITHIN THE JURISDICTION OF THIS MUNICIPALITY

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers every local government unit to exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the State, under Republic Act No. 11641 or the "Department of Migrant Workers Act", has institutionalized the commitment to protect the rights and promote the welfare of Overseas Filipino Workers (OFWs) and their families, mandating the DMW to formulate and implement policies and programs to this effect;

WHEREAS, the Municipality of Taytay and the entire Province of Rizal are home to a significant and ever-growing population of OFWs, whose immense contributions through remittances are a vital driver of our local and national economy, and whose welfare and protection remain a paramount concern of this local government;

WHEREAS, the establishment of a Department of Migrant Workers Provincial Office is a strategic imperative to decentralize its functions and bring its comprehensive services closer to the very people it is mandated to serve, thereby reducing the travel time, expenses, and difficulties currently faced by Rizaleño OFWs and their families in accessing said services;

WHEREAS, the proposed establishment of the DMW Rizal Provincial Office in Taytay will provide our constituents with direct and convenient access to a full spectrum of critical services, which include but are not limited to:

- Processing Services: Efficient handling of walk-in queries, issuance of Balik-Manggagawa documents such as the Overseas Employment Certificate (OEC), issuance of OFW Information Sheets, verification of records, and assistance in E-Registration, Government-to-Government (G2G) hiring, and other related processes;
- Protection Services: Immediate assistance for labor-related grievances, on-site legal advice, and endorsement to mechanisms such as the Single Entry Approach (SEnA) for conciliation and mediation, ensuring that the rights of our OFWs are upheld and protected from the moment of hiring to their return;
- Welfare and Reintegration Services: Holistic support for OFWs and their families through programs such as the Livelihood Programs for OFW Reintegration (LPOR), the 'Sa Pinas, Ikaw ang Ma'am at Sir' (SPIMS) Program for returning OFW teachers, financial assistance for victims of Balikbayan Box Scams, and the provision of psycho-social interventions for those in distress;
- Emergency and Financial Assistance: Swift processing of aid through AKSYON Fund Programs covering repatriation, medical assistance, and death claims; timely assistance to families affected by natural calamities; and aid in the shipment of the remains of deceased OFWs; and
- Empowerment and Development Programs: Regular conduct of Financial Awareness Seminars - Small Business Management Trainings (FAS-SBMT), Pre-Migration Orientation Seminars (PMOS), and Anti-Illegal Recruitment and Trafficking in Person (AIR-TIP) Seminars to empower OFWs with knowledge and protect them from exploitation;

WHEREAS, this strategic partnership will create a synergetic relationship mutually beneficial to both parties: the Municipality of Taytay, by hosting the DMW, will solidify its stature as a prime center of governance and public service in Rizal, fostering local economic activity through the influx of clientele from neighboring towns, and directly responding to the needs of a vital sector of its constituency; reciprocally, the Department of Migrant Workers will gain an ideal and accessible location for its provincial operations, benefiting from the full support and collaboration of the Local Government Unit, particularly through our Public Employment Service Office (PESO), in the conduct of job fairs, reintegration caravans, and other joint programs;

WHEREAS, the Sangguniang Bayan finds this undertaking to be in complete alignment with the development agenda of the Municipal Government under the leadership of Mayor Allan Martine S. De Leon, which prioritizes the well-being of every Taytayeño, especially our modern-day heroes and their families;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to AUTHORIZE THE HONORABLE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPALITY OF TAYTAY, RIZAL, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF MIGRANT WORKERS (DMW), REPRESENTED BY ITS CALABARZON REGIONAL DIRECTOR, ATTY. APRIL R. CASABUENA, FOR THE ESTABLISHMENT OF THE DMW RIZAL PROVINCIAL OFFICE WITHIN THE JURISDICTION OF THIS MUNICIPALITY.


