WHEREAS, recent earthquakes experienced in various parts of the country have raised concerns on the level of preparedness of both residents and public utility service providers in responding to such emergencies;

WHEREAS, tricycle drivers, being one of the most visible and numerous public service operators in the municipality, play a crucial role in ensuring mobility and emergency response in times of disaster;

WHEREAS, the Taytay Municipal Disaster Risk Reduction Management Office shall undertake proactive measure by conducting safety and disaster preparedness seminar together with providing tricycle drivers a GO BAG-containing basic emergency supplies such as water, flashlight, first-aid kit, emergency contact list, whistle, and face masks will significantly improve personal and passenger safety during unexpected calamities;

WHEREAS, the provision of GO BAGS may be facilitated through the support of the Local Government Unit and the coordination with the Taytay Municipal Tricycle Franchising And Regulatory Office (TMTFRO) ensuring uniformity and compliance among member drivers;
