WHEREAS, pursuant to Section 57, Chapter III, Title I, Book III of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, all barangay ordinances shall be reviewed by the Sangguniang Bayan to ensure that such measures are consistent with law and municipal ordinances;

WHEREAS, the Sangguniang Bayan of Taytay, Rizal, through its Committee on Solid Waste Management, has conducted a thorough review and evaluation of Barangay Ordinance No. 10, Series of 2025, and found it in conformity with the provisions of Republic Act No. 9003, otherwise known as the *Ecological Solid Waste Management Act of 2000*, and Republic Act No. 7160;

WHEREAS, the Sangguniang Barangay of Muzon, Taytay, Rizal enacted Barangay Ordinance No. 10, Series of 2025, entitled: “*A Barangay Ordinance Enacting the Solid Waste Management Ordinance of Barangay Muzon, Taytay, Rizal*”, during its 41st Regular Session held on July 17, 2025;

WHEREAS, after due deliberation, the Sangguniang Bayan of Taytay finds the said Barangay Ordinance to be valid, consistent with existing laws, and beneficial to the residents of Barangay Muzon and the Municipality of Taytay as a whole;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to APPROVE IN REVIEW BARANGAY ORDINANCE NO. 10, SERIES OF 2025, ENTITLED: “A BARANGAY ORDINANCE ENACTING THE SOLID WASTE MANAGEMENT ORDINANCE OF BARANGAY MUZON, TAYTAY, RIZAL”.
