**RESOLUTION NO. 75 series of 2025**

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH NATIONAL ICT CONFEDERATION OF THE PHILIPPINES, REPRESENTED HEREIN BY ITS PRESIDENT JESSRAF PALMARES, FOR THE CONDUCT OF THE 17<sup>TH</sup> NATIONAL ICT SUMMIT 2025 IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES**

WHEREAS, Section 24, Article II of the 1987 Philippine Constitution states that, “*the State recognizes the vital role of communication and information in nation-building*”;

WHEREAS, the Department of the Interior and Local Government (“DILG”) issued an Advisory dated 15 September 2025, which states that the NICT, in partnership with DICT and DILG, will be conducting the 17<sup>th</sup> National ICT Summit 2025 in the Municipality of Taytay, Province of Rizal on 13-15 November 2025;

WHEREAS, the National ICT Confederation of the Philippines (“NICP”) is the national umbrella organization of all information and communications technology (“ICT”) councils from Luzon, Visayas, and Mindanao, composed of local stakeholders, including local governments, private and-business sectors, industry, academe, and the human resource sector, working together to promote their respective locations as investment destinations for ICT-related industries and jobs;

WHEREAS, the NICP has been instrumental in supporting the Department of Information and Communications Technology (“DICT”), the primary agency mandated to develop the national ICT development agenda, in the conduct of annual national ICT summits and cluster conferences in various cities throughout the country;

WHEREAS, the ICT summit aims to offer a variety of locations for ICT-related direct foreign or local investments or joint venture arrangements, particularly in voice and non-voice global services, HR, back-office support, shared services outsourcing, finance and accounting, research and development, and knowledge process and creative process outsourcing (game development, animation, multi-media, and advertising), health information management, medical coding, billing, and transcription;

WHEREAS, the Municipal Government of Taytay, Rizal, recognizes the importance of ICT in promoting local economic development, innovation, and public service efficiency;

WHEREAS, the Municipal Government of Taytay, Rizal, has agreed to host the 17<sup>th</sup> National ICT Summit 2025 to promote ICT-related investments and collaboration in the municipality;

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement (“MOA”) to formalize the cooperation and ensure the successful conduct of the said summit;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the negotiation of MOA with NICP will strengthen the mission of the Municipal Government to meet the needs of its inhabitants;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH NATIONAL ICT CONFEDERATION OF THE PHILIPPINES, REPRESENTED HEREIN BY ITS PRESIDENT JESSRAF PALMARES, FOR THE CONDUCT OF THE NATIONAL ICT SUMMIT IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMORE, that copies of this Resolution be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
