DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION FOR THE IMPLEMENTATION OF TECHNICAL-VOCATIONAL-LIVELIHOOD ASSESSMENT CENTER IN TAYTAY SENIOR HIGH SCHOOL, REPRESENTED HEREIN BY ITS SCHOOL PRINCIPAL II, ANGELA R. AGAS, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the *Local Government Code of* 1991, provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 12 of R.A. 10533, also known as the "Enhanced Basic Education Act of 2013", states that Department of Education ("DepEd"), Commission on Higher Education ("CHED"), Technical Education and Skills Development Authority ("TESDA"), Technical-Vocational Institutions ("TVIs"), and Higher Education Institutions ("HEIs") shall coordinate closely to implement strategies that ensure academic, physical, financial, and human resource capabilities;

WHEREAS, the DepEd Order adopts the process for availing the TESDA's free assessments for Senior High School ("SHS") Technical-Vocational-Livelihood ("TVL") learners and free training, assessment, and accreditation for assessors among teaching and non-teaching personnel in public and private schools;

WHEREAS, Taytay Senior High School offers the TVL Track to Senior High School students, including specialization in Food and Beverage Services ("FBS") and Shielded Metal Arc Welding ("SMAW");

WHEREAS, the accreditation of the School's Food Laboratory and SMAW Laboratory as a TESDA Assessment Center will provide students with accessible, affordable, and quality national assessment services within the locality of Taytay;

WHEREAS, the establishment of the said assessment center will encourage more students to pursue studies under the TVL Track and undergo competency assessments, knowing that a local and accredited facility is readily available;

WHEREAS, the Municipality of Government of Taytay, Rizal is encouraged to fully support the implementation of quality-assured assessment for the national certification of learners in the senior high school technical-vocational-livelihood track and expansion of the number of competency assessors;

WHEREAS, the Municipal Government of Taytay, Rizal, recognizes the need for an assessment center that is safe for the students and teachers, and conducive to learning, and has the capability to provide quality assessment;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the establishment of an assessment center within the school will bring accessible certification opportunities to the local community, promote employment, and uplift the standards of wellness and industrial practice in the Municipality of Taytay, Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF **EDUCATION** FOR IMPLEMENTATION OF TECHNICAL-VOCATIONAL-LIVELIHOOD ASSESSMENT CENTER IN TAYTAY SENIOR HIGH SCHOOL, REPRESENTED HEREIN BY ITS SCHOOL PRINCIPAL II, ANGELA R. AGAS, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FINALLY, that copies of this Resolution be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay, Rizal and National Government Agencies.
