WHEREAS, the Technical Education and Skills Development Authority (TESDA) is mandated to provide relevant, accessible, high quality technical education and skills development in support of the development of high-quality Filipino workforce;

WHEREAS, under the DepEd Order No. 003 series of 2025, it provides an updated framework for implementing quality-assured assessment for the National Certification of learners in the Senior High School Technical-Vocational-Livelihood (SHS-TVL) Track that establishes a more robust system for assessment, certification, and the expansion of accredited assessors, with the goal of enhancing the employability of TVL graduates;

WHEREAS, based on TESDA Circular No. 046 series 2025, the Department of Education and the Technical Education and Skills Development Authority (TESDA) have collaboratively amended the Implementing Guidelines to further strengthen the quality-assured assessment process for the certification of Senior High School (SHS) learners under the Technical Vocational Livelihood (TVL) Track;

WHEREAS, it was also stated in the said TESDA Circular, that the DepEd and TESDA have agreed in the Supplemental Guidelines to Ensure Quality-Assured Assessment for Certification of Senior High School Technical-Vocational-Livelihood Track to provide further guidance to ensure the quality-assured assessments for certification of SHS TVL learners;

WHEREAS, the National Competency Certification of the Technical Education and Skills Development Authority (TESDA) were part of the Curriculum of the Senior High School (SHS) Program for students in the Technical-Vocational-Livelihood (TVL) Track;

WHEREAS, Shield Metal Arc Welding and Food and Beverage Service is among the qualifications recognized by TESDA under its National Competency (NC) programs to promote

their skills development, efficient technical education and to maximize their technical-vocational capabilities;

WHEREAS, Taytay Senior High School has expressed its readiness, and meets the requirements to serve as an accredited TESDA Assessment Center for Shield Metal Arc Welding and Food and Beverage Service providing a venue for learners and practitioners to undergo proper competency assessment and certification;

WHEREAS, the establishment of an assessment center within the school will bring accessible certification opportunities to the local community, promote employment, and uplift the standards of the school in the Municipality;

WHEREAS, the Local Government of Taytay, Rizal recognizes the significance of this initiative and fully supports the school's intention to become a TESDA-accredited Assessment Center for Shield Metal Arc Welding and Food and Beverage Service;


