WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides, in part, that every local government unit shall exercise powers necessary for its efficient and effective governance, as well as those essential to the promotion of the general welfare;

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each Local Government Unit shall have a comprehensive, multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian Bayan;

WHEREAS, the Taytay Development Council (TDC) shall assist the Sanggunian Bayan (SB) in setting the direction of development efforts within the municipality;

WHEREAS, the Annual Investment Program (AIP) is the annual slice of the Local Development Investment Plan / Executive - Legislative Agenda (LDIP / ELA), referring to the indicative yearly expenditure requirements of the LGUs' programs, projects and activities (PPAs) to be integrated into the annual budget;

WHEREAS, there is a need to formulate the Annual Investment Program (AIP) for Calendar Year 2026 to support the development of this municipality in the areas of social, economic, human and ecological security, education, and infrastructure;

WHEREAS, after thorough deliberation, the members of the Taytay Development Council (TDC) unanimously approved the Annual Investment Program (AIP) CY 2026, upon the motion of Hon. Jean Lalaine P. Calderon duly seconded by Hon. Reinier Andrew S. Pacleb, and recommend such to the Sanggunian Bayan for adoption;

WHEREAS, the Annual Investment Program (AIP) for Calendar Year 2026 has a total allocation of Six Billion Three Hundred Ninety-Six Million Six Hundred Seventy Thousand Eight
