WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers necessary for the efficient and effective governance and the promotion of the general welfare;

WHEREAS, pursuant to Republic Act No. 9344, as amended by Republic Act No. 10630, and relevant DILG Memorandum Circulars, Local Government Units are mandated to establish and strengthen their Local Council for the Protection of Children (LCPC) to ensure the protection and promotion of children's rights at the local level;

WHEREAS, the Local Council for the Protection of Children (LCPC) is the primary inter-agency mechanism at the local level who are responsible for planning, coordinating, and monitoring programs and activities related to child protection, child rights advocacy, and overall child development;

WHEREAS, the LCPC is required to formulate an Annual Work and Financial Plan (AWFP) to outline its programs, projects, and activities (PPAs) that promotes the welfare, protection and development of children in the municipality and its corresponding budgetary requirements for the year;

WHEREAS, after thorough review and deliberation, the LCPC has finalized its Annual Work and Financial Plan for CY 2025, which is aligned with the Local Development Plan, LCPC Functionality Indicators, and national policies on child rights governance;

WHEREAS, the approval of the LCPC AWFP for CY 2025 and ratifying their resolution is necessary to ensure the effective implementation and funding of child protection programs within the locality;

WHEREAS, the Sangguniang Bayan recognizes the importance of supporting and institutionalizing the LCPC's annual plan to ensure the effective implementation of child protection mechanisms and compliance with national standards and guidelines;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES THE ANNUAL WORK AND FINANCIAL PLAN (AWFP) OF THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) FOR CALENDAR YEAR 2025 AND RATIFIES THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) RESOLUTION NO. 02 SERIES OF 2025.
