WHEREAS, Republic Act No. 9208, as amended by Republic Act No. 10364 or the “Expanded Anti-Trafficking in Persons Act”, mandates all local government units to establish functional mechanisms to prevent, address, and respond to trafficking in persons;

WHEREAS, Republic Act No. 9262, otherwise known as the “Anti-Violence Against Women and Their Children Act of 2004”, further requires local government units to strengthen protective systems for women and children who are victims of abuse and violence;

WHEREAS, pursuant to national directives and DILG Memorandum Circular No. 2023-181, the Local Government Units are required to organize or reorganize and strengthen their Local Committee Against Trafficking - Violence Against Women and Their Children (LCAT-VAWC) to develop plans, programs, and interventions to ensure the effective prevention, response, and coordination of efforts against trafficking, abuse, and violence and prepare an Annual Work and Financial Plan (AWFP) to guide the implementation of its programs, projects and activities (PPAs);

WHEREAS, the LCAT-VAWC has duly prepared and finalized its Annual Work and Financial Plan (AWFP) for Calendar Year 2025, setting forth its planned PPAs and corresponding budgetary requirements to ensure the effective prevention, response and coordination against trafficking and VAWC;

WHEREAS, after deliberation and evaluation, the LCAT-VAWC approved LCAT-VAWC Resolution No. 02, Series of 2025, endorsing the said AWFP for confirmation and approval by the Sangguniang Bayan;

WHEREAS, the Sangguniang Bayan recognizes the necessity of supporting and institutionalizing the AWFP to ensure the sustained implementation of protective, preventive, and responsive measures for women and children in the locality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES THE ANNUAL WORK AND FINANCIAL PLAN (AWFP) OF THE LOCAL COMMITTEE AGAINST TRAFFICKING - VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) FOR CALENDAR YEAR 2025 AND RATIFIES THE LOCAL COMMITTEE AGAINST TRAFFICKING - VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) RESOLUTION NO. 02, SERIES OF 2025.
