WHEREAS, under Republic Act No. 9155, otherwise known as the “Governance of Basic Education Act of 2001”, it is the policy of the State to protect and promote the right of all citizens to quality basic education and to make such education accessible to all learners;

WHEREAS, Republic Act No. 7160 otherwise known as Local Government Code of 1991 mandates local government units to ensure and support the delivery of basic services and to promote the educational services within their territorial jurisdiction;

WHEREAS, the Taytay Integrated School currently caters to learners at the secondary level but has no created elementary level, to better respond to the educational needs of children as well as its accessibility and safety for school-aged children in the locality;

WHEREAS, the creation of an elementary level within the Taytay Integrated School will greatly benefit learners by providing safer, more accessible, and more inclusive basic education, especially for children residing in the nearby areas and reduce school overcrowding in nearby institutions and enhance the overall learning environment for children;

WHEREAS, the Department of Education (DepEd) encourages the expansion of the Taytay Integrated School to include complete basic education offerings, ensuring continuity of learning from Grade 1 to Grade 12;

WHEREAS, the Local School Board on its regular board meeting affirmed the body's full support for the creation of Elementary Level in the Taytay Integrated School to better serve the students residing from the barangay where the school is located;

WHEREAS, the Principal III of Taytay Integrated School wrote a letter dated November 14, 2025, requesting the Sangguniang Bayan of Taytay, Rizal for a resolution supporting the creation of Elementary Level in the said Integrated School;

WHEREAS, the Local Government Unit of Taytay under the leadership of Mayor Allan Martine S. De Leon, MPA and the 13<sup>th</sup> Sangguniang Bayan express their full support for the creation of Elementary Level in the Taytay Integrated School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby EXPRESSES SUPPORT FOR THE CREATION OF ELEMENTARY LEVEL IN THE TAYTAY INTEGRATED SCHOOL FOR THE IMPROVEMENT OF EDUCATIONAL OPPORTUNITIES FOR CHILDREN IN OUR LOCALITY.
