DE LEON, MPA, TO NEGOTIATE, SIGN, AND ENTER INTO A MEMORANDUM OF AGREEMENT (TRIPARTITE AGREEMENT) WITH LIFE SAVER MEDICAL SERVICES REPRESENTED HEREIN BY ITS CORPORATE OPERATING OFFICER, MS. JEROWIE O. LALAN, AND WITH LET’S CARE WORLDWIDE FOUNDATION, REPRESENTED HEREIN BY ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, DR. TURKZ B. WHEREAS, Section 15, Article II of the 1987 Philippine Constitution declares that “*the State shall protect and promote the right to health of the people and instill health consciousness among them*”;

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution mandates that “*the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost, with priority to the underprivileged, sick, elderly, disabled, women, and children*”;

WHEREAS, Section 2, Chapter I of Republic Act (“R.A.”) No. 11223, otherwise known as “Universal Health Care Act” states that, “[i]t is the policy of the State to protect and promote the right to health of all Filipinos and instill health consciousness among them”;

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement (“MOA”) (Tripartite Agreement) with Life Saver Medical Services and Let’s Care WorldWide Foundation, for implementing the PhilHealth YAKAP Program and Community-Based Health and Social Development Initiative for all Taytayeño constituents;

LALAN, AND WITH LET’S CARE WORLDWIDE FOUNDATION, REPRESENTED HEREIN BY ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, DR. TURKZ B. HUSSEIN, FOR THE IMPLEMENTATION OF THE PHILHEALTH YAMAN NG KALUSUGAN (“YAKAP”) PROGRAM AND COMMUNITY-BASED HEALTH AND SOCIAL DEVELOPMENT INITIATIVE IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.


